**JOINT MOTION FOR PARTIAL STAY OF PROCEEDINGS**

In accordance with the Court's Order of October 11, 2013, the parties have met and conferred regarding the Movants' request for access to unredacted versions of the Government's response and declaration. The parties have been unable to reach agreement on this issue, and after informing the Government that they intended to seek relief from the Court in regard to the

Government's redacted submissions, on November 12, 2013, Movants filed their Motion to Strike the Government's *Ex Parte* Response to Motions to Disclose Aggregate Data Regarding FISA Orders.

Accordingly, the parties hereby jointly move for a stay of the deadline for the Movants' reply to the Government's response to the Movants' motions for declaratory relief. The parties request that the Court stay the deadline for the Movants' reply until the Court resolves the Movants' pending motion for relief in regard to the Government's redacted submissions. At that point in time, the deadline for the Movants' reply can be re-set as appropriate under the circumstances. The parties propose that the Government's opposition to Movants' motion for relief in regard to the Government's redacted submissions be filed on or before December 6, 2013, and that the Movants' reply with respect to that motion be filed on or before December 20, 2013. A proposed Order is attached.
